## Pharmacy and Northern Health

Earlier this year, there was a widely reported issue at the Northern Hospital involving the usage of medicinal cannabis as part of the treatment of a young boy with quite severe disabilities.

The cannabis was neither prescribed nor dispensed by clinicians at the Northern.

A media circus occurred at the time, with stories being run in the Herald-Sun, on TV and in other media. Police became involved – the issue was brought directly to the attention of the Chief Commissioner – and a major public debate was stirred, with most of the debate being political in nature.

In amongst this, a member of ours was summoned to disciplinary proceedings. Northern Health's management felt "unable" to wait to see the outcome of any police investigation and insisted on bringing the matter to a head. Our member was put under an enormous amount of pressure with the hospital conducting multiple layers of investigations but ultimately our member was left stuck in the middle.

The AHP sprung to our member's defence, ensuring the best possible representation at a time when the Hospital was lashing out in all directions. As a result of our intervention, our member was able to get through the process with career intact and the outcome minimised.

If not a union member, this person would have been on their own, fighting expensive legal battles out of their own pocket, and lacking good strategic advice. It pays to be a union member.

## National Mental Health Commission findings to be released

The Australian Government has asked the National Mental Health Commission to conduct the 2014 National Review of Existing Mental Health Programmes and Services across the country. Many members made submissions to the review in March and April of this year and we await the final report to government, due prior the 30th November.

The VPA has been concerned for sometime about the reductions of public mental health services because we know that mental health is an issue for everyone in our community. We are particularly interested in how the Commission addresses issue of access and availability and will consider a response to the report on its release.

## The Christmas close down period and you

It has come to our attention that a number of employers are already trying to coerce members into taking annual leave to cover their close down periods.

It is very clear from our public sector Enterprise Bargaining Agreement and most of our private sector agreements that there is no capacity for your employer to force you to take annual leave or long service leave for this purpose.

It is not acceptable for your employer to make arrangements about close down periods under the assumption that staff will be required to use annual leave or long service leave to cover it.

Remember: there is no requirement for anyone to agree to take annual leave or long service leave to cover regular working days over the Christmas and New Year period.
