# Union appears before Senate Select Committee on Health

On Thursday the Union appeared before the Senate Select Committee on Health. It was incredibly rewarding to be able to share our concerns about hospital funding, workforce planning, pathology and the National Blood Authority.

The Committee was very interested in our views about workforce planning, especially in light of our work around the extent of unpaid work; increases in workloads and the tendency for management to cut services in less visible areas like pathology, pharmacies and in mental health.

It was also an excellent opportunity to highlight our ongoing concerns about the hospital and health funding and the flow impacts that funding cuts have on health services.

The Committee has requested additional information and submissions from us which we are in the process of compiling.

The Committee will continue its schedule of hearings and is due to report back to the Parliament on 20 June next year.

#### **Seminar Title:**

What Every Psychologist Can Do to Help Client with Substance Use Issues

#### **Seminar Abstract:**

Alcohol and Other Drug Use is common in our society. Not everyone who uses substances experiences problems, however significant numbers of people do. Approximately 50% of people suffering from a mental disorder also have a co-occurring substance use disorder. Despite this the rates of screening and assessment for substance use problems in health services are low, and interventions provided are even lower.

This workshop will discuss the substances of concern in our community and what treatment options are available. Participants will be introduced to a screening tool to assist them in ascertaining if their clients have a substance use issue and learn how to provide a brief intervention.

### What happened to ANZAC Day?

You might have started wondering what happened to ANZAC Day this year. We've certainly heard a lot of fanfare about it with this year being the centenary. But you'll have probably discovered that ANZAC Day falls on a Saturday this year and there is no substitute day.

But what does this mean to you?

If you work full-time Monday to Friday: You are entitled to receive one and half day's pay in addition to the weekly wage or one and half days off at a time convenient to the Employer without loss of pay in lieu.

If you are a full-time shift worker and are not required to work on Easter Sunday you are entitled to receive one and half day's pay in addition to the weekly wage, or one and half days off at a time convenient to the Employer without loss of pay in lieu.

# Easter payments proving too difficult for health services to understand

Unfortunately it seems that many so-called HR and payroll professionals in Victoria's health services appear to lack the necessary comprehension skills needed to perform their jobs. This is the only conclusion we can come up with as members across Victoria are reporting health services refusing to pay Easter Saturday and Easter Sunday entitlements, contrary to the advice their own industrial advisers have given them.

Make no mistake these are your entitlements and will continue to fight for them being given to you.

We are pursuing each health service to ensure our members are paid their entitlements. The Union is also with the Victorian Health Industry Association to ensure they're advising health services about their obligations to pay your Easter Saturday and Easter Sunday entitlements.

# Worth Reading: Unions Call For An End To Shadowy Trans-Pacific Partnership Talks

"The Australian Council of Trade Unions, backed by the International Trade Union Confederation, has today reiterated its calls for the federal government to cease negotiations over the controversial Trans-Pacific Partnership.

The US-led trade deal is being negotiated in secret by 12 countries, and could result in higher medical prices and allow corporations to sue governments for policy designed to protect the public, if it hurts their profits.

Tobacco giant Phillip Morris is already suing the Australian government under the provisions of a 1993 free trade deal known as the 'Hong Kong Agreement', and critics say that such lawsuits could extend to environmental, copyright and workplace laws if the Trans-Pacific Partnership (TPP) goes ahead."
